## 2. Hazard identification

Classification of the substance and mixture:

### 4. First-Aid Measures

#### General advice:

If difficulties occur after vapour/aerosol has been inhaled, remove to fresh air and seek medical attention.

#### On contact with eyes:

Wash affected eyes for at least 15 minutes under running water with eyelids held open, consult an eye specialist.

Rinse mouth immediately and then drink plenty of water, seek medical attention. Do not induce vomiting.

#### Note to physician:

## 6. Accidental Release Measures

Personal precautions:

## 7. Handling and Storage

### Handling

### Storage

Suitable materials for containers: High density polyethylene (HDPE), Low density polyethylene (LDPE), Carbon steel (Iron)

Further information on storage conditions: Keep only in the original container in a cool, dry, well-ventilated place away from ignition sources, heat or flame. Protect from direct sunlight.

Storage stability:

Storage temperature: 5 - 50 °C

Protect from temperatures below: 5 °C

The packed product is destroyed at low temperatures or by frost.
