**Danger****Hazard Statement:**

Causes serious eye damage. Harmful if inhaled. May cause an allergic skin reaction. May cause respiratory irritation.

**Precautionary Statements (Prevention):**

## 4. First-Aid Measures

### General advice:

First aid personnel should pay attention to their own safety. Immediately remove contaminated clothing.

### If inhaled:

If difficulties occur after vapour/aerosol has been inhaled, remove to fresh air and seek medical attention.

### On skin contact:

After contact with skin, wash immediately with plenty of water and soap. Under no circumstances should organic solvent be used. If irritation develops, seek medical attention.

### On contact with eyes:

Wash affected eyes for at least 15 minutes under running water with eyelids held open, consult an eye specialist.

### On ingestion:

Rinse mouth immediately and then drink plenty of water, seek medical attention. Do not induce vomiting unless told to by a poison control center or doctor.

### Note to physician:

## 5. Fire-Fighting Measures

### Suitable extinguishing media:

## 6. Accidental Release Measures

### Handling

**Body protection:**
