Polycarboxylic ether based superplasticizer for the production of high quality ready-mix concrete with exceptional workability retention.

DESCRIPTION

MasterGlenium 195QA is an innovative latest generation superplasticizer based on polycarboxylic ether (PCE) polymers, and is specially engineered for ready-mix concrete.

MasterGlenium 195QA is differentiated from conventional superplasticisers, such as those based on sulphonated naphthalene formaldehyde condensate in that it is based on a unique carboxylic ether polymer with long lateral chains. This greatly improves cement dispersion. At the start of the mixing process the same electrostatic dispersion occurs but the presence of the lateral chains, linked to the polymer backbone, generate a steric hindrance which stabilises the cement particles capacity to separate and disperse. This mechanism provides flowable concrete with greatly reduced water demand.

APPLICATION PROCEDURE

DOSAGE

The normally recommended dosage rate of **MasterGlenium 195QA** is 0.6 to 2.25 litre per 100kg of total cementitious material.

Other dosages may be recommended in special cases according to the specific site conditions. In this case please consult our Technical Services Department for advice.

MIXING

MasterGlenium 195QA is a ready-to-use admixture to be added to the concrete as a separate component. Optimal result is obtained if **MasterGlenium 195QA** is poured into the concrete mix right after the addition of the first 80% of the mixing water, i.e. when all solids are wetted. Avoid adding the admixture to the dry aggregates.

COMPATIBILITY

MasterGlenium 195QA is not compatible with **MasterRheobuild** superplasticizers.

MasterGlenium 195QA is suitable for mixes containing:

- Microsilica (Silica Fume)
- Fly Ash (PFA)
- GGBS (ground granulated blast furnace slag)

STORAGE

MasterGlenium 195QA should be stored in unopened containers or bulk tanks so as to protect from extremes of temperature.

The shelf life is 1 year when stored as above

The occurrence of a surface layer with **MasterGlenium 195QA** is normal and will have no effect on the performance of the product.

HANDLING AND TRANSPORTATION

No special requirements must be observed during use. Protection gloves and glasses are however recommended. **MasterGlenium 195QA** is non-flammable, non-toxic or irritant and is not subject to special transport requirements.
